Polar Holds 2010 Annual Meeting

The Annual Members Meeting of Polar Communications was held on Thursday, June 10, 2010. A total of 309 members registered during the meeting. Members and guests were served a meal prior to the meeting.

Dan Stenvold, Mayor of Park River, welcomed the attendees to Park River, Pastor Jeff Johnson gave the invocation, and Lt. Governor Jack Dalrymple addressed the membership.

Three directors were re-elected to Polar's board of directors. Amber Meyer of St. Thomas will represent District 1; Jon McMillan of Fordville will represent District 2; and Greg Steffes of Arthur will represent District 3. All three directors will serve a three-year term.

Members voted on a proposed by-law amendment as follows: ARTICLE IV. DIRECTORS. SECTION 2. **Election and Tenure of Office.** Directors shall be elected by a secret ballot at each annual meeting when there is competition for the board seat(s) to be filled. They shall be elected by and from the members to serve a three (3) year term, or until their successors shall have been elected and shall have qualified, and that terms of the directors shall be staggered to

insure continuity. No more than one (1) director shall be elected or serving from any one telephone exchange at the same time. No member shall be allowed to serve as a director for more than ~~five~~ **seven** consecutive elected terms. If an election of directors shall not be held on the day designated herein for the annual meeting, or at any adjournment thereof, a special meeting of the members shall be held for the purpose of electing directors at a reasonable time thereafter. Directors shall be nominated and elected as provided hereinafter. Directors shall be elected by a plurality vote of the

The 2010 construction project is underway. Crews are currently working in the city of Park River, rural Niagara and Grafton. Polar will also be doing construction in the Aneta, Petersburg and Larimore areas later this summer.

Our inside wiring contractors are currently rewiring homes in the city of Park River. This will continue through the next few months and will expand to the Aneta and Petersburg areas.

Cut-overs will begin in the Park River exchange after the splicing of the fiber routes are complete. The cut-overs will begin late July and continue through early 2011.

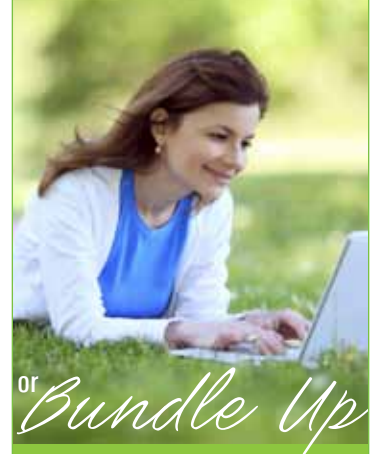
Jody and her husband, Bill, reside in Minto, North Dakota. They have two grown children and enjoy spending time with their five grandchildren.
