Polar's 2011 construction project will upgrade the city of Cavalier to fiber-to-the-home Services. Construction started May 31st and will continue into fall. There are several phases to the construction project. Currently Polar's inside wiring contractors, Jeff Carlson Services (JCS), are rewiring homes in Cavalier. This will continue for the next few months. Our contractor, Arvig Communication Services (ACS), is currently doing ground work in the city of Cavalier, placing fiber from Polar's central office to the homes. When this phase is finished, splicing of the fiber routes will be completed and cutovers to the new service will be started. Cutovers will begin in late August and continue through the middle of 2012.

# Don't Get Arrested

*for someone using your wireless network!*



**If your wireless network is not secure, someone sitting across the street from your home can access your network to do illegal activities...and YOU may be responsible!**

Many people enjoy the convenience of having a wireless network in their home or business. All you need is a wired connection and a wireless router to broadcast a signal allowing online access throughout your home or business. But unless your network is password protected and secured, you may be sharing your access with others. Anyone using your wireless network, whether you know it or not, is traced back to you.

Let's look at some of the things that can happen when others access your unsecured wireless network. 1) Your bandwidth use is increased with more users on your network. It's important to keep your bandwidth under control to maximize your speeds. Also, more people accessing your router can cause it to overload, slow down and require resets. 2) Hackers may be able to access your private documents, pictures, files and other devices and computers on the network. Your identity may even be stolen. 3) You may be supporting criminal activities. If other people are accessing your wireless network, you have no control over what they're doing. Music pirating, illegal gambling and worse can be happening using your internet. **You may have to face legal liability issues if these activities are traced to your IP address.**

Secure that network! Put a password on your wireless connection, both the wi-fi access point and the computer. Do not use default passwords or account names and make sure you use a "strong" password that includes both numbers and letters.
